

Privacy Policy

The purpose of this privacy policy is to inform you about the personal data that Camera Obscura Hub, (hereinafter the "controller") processes them for you. Based on the Law on the Protection of Personal Data (in hereinafter "the law") when collecting your personal data, we act as controller and we are obliged to inform you about the processing thereof. The processing of your personal data is a very serious activity for us and we take all necessary measures technical and organizational measures to protect the processing of your personal data. Also, when processing your personal data, we are always guided by the principles related to the processing of personal data, provided for in the law.

This policy applies to all categories of personal data subjects, whose data we process in accordance with the law.

Categories of personal data subjects

We as a controller to fulfill our legal obligations, contractual obligations, for normal functioning of the organization, meeting the objectives of the project, as well as in accordance with nature of the organization's operations, we process the personal data of the following categories of personal data subjects:

- Visitors to the web page – data for navigation, that is, necessary cookies for normal functioning of the website. See more in the cookie policy,
- Employees – data is processed based on the records law of the area of labor, the law on labor relations, as well as other laws that govern this area,
- Candidates for employment – data is processed to fulfill the contractual obligations, i.e. employment of the respective candidate,
- Training participants – data is processed based on your consent to participation in trainings organized by the project,
- Personal data of hired persons (consultants and external collaborators) – data is processed to fulfill contractual obligations arising from concluded agreement with the hired persons.

How do we collect your personal data?

Your personal data that we process or collect for you as visitors to our site website, during your visit our website contains navigation data ie necessary cookies for the normal functioning of our website (more information in cookie policy).

We also use the website to inform the public with announcements, activities, publication of data that we are obliged to publish about the organization, as well as data about contact (address of the organization, phone number, email address and information about the coordinator for the protection of personal data).

Visitors to our website

When visiting our website, logs with the following are created for each visitor data:

- Your Internet Protocol (IP) address.

- The device you are accessing from, type and model.
 - Your operating system.
 - Type of search engine, plugins and version.
 - The pages you visit on our website and the time you spend on each side.
 - The URL of the page that referred you to our website and in some cases, the terms which you used in trying to find our website.
 - The language of the browser you are using.
 - Country (determined by the IP address).
